- Attend training classes to remain current in knowledge of standards, job requirements and pre-requisite skills.
- Perform baseline qualitative and quantitative exposure assessments for all production, laboratory and maintenance activities.
- Maintain the company's Personal Protective Equipment and Respiratory Protection Programs.
- Manage and maintain SDS's for all chemicals handled on site.
- Maintain the company's HAZCOM program.
- Help develop and maintain Job Hazard Analyses.
- Assist with developing annual objectives with the Worker's Compensation insurer.
- Maintain a general knowledge of OSHA regulations, especially those that pertain to worker protections.
- Perform miscellaneous job-related duties as assigned by the Safety and Health Manager.
- Evaluate ergonomic risks and work to develop solutions.
